- Minimum three-year commitment required
- Retailer commits to New Item/Speed to Shelf of Tier 1 launches
- Counseling by Shelf Management Representative
- Limited 2-3 day full store refresh
 - Refresh executed once per year
 - Center store refresh (Grocery, Frozen, Dairy and GMHBC)
 - All Center store departments reset at same time
- Shelf Management Representative led reset
 - 3rd-Party Labor resource assisted
- Refresh focus on optimizing item assortment
 - New items
 - Key items
